**WAIVER OF LIABILITY
(Required for Valid Entry)**

- The Owner/Skipper hereby agrees: to adhere to and abide by all of the provisions of the J/35 Association, the Etobicoke Yacht Club, the J/35 North American's Regatta Committee, Sailing Instructions, the Racing Rules of sailing and general conditions; and confirms that the boat is well founded and in seaworthy condition and that the Owner and crew enter these races of their own desire, governed by the rules of good sportsmanship. It is therefore agreed that neither the Owner/Skipper nor members of the crew shall in any way whatsoever hold the J35 North American's Regatta, the Etobicoke Yacht Club, the officers, directors, committee chairpersons and employees of the Etobicoke Yacht Club and/or the J35 North American's Regatta Committee, the Race Committee or the Protest Committee, or any of them in whole or in part, liable for any damage, accident or loss, including personal injury or loss of life, occurring, suffered or happening to the boat, the Owner/Skipper or any member of the crew, while on the water or on shore. The Owner/Skipper also agrees to obtain a similar release in favour of the releasees from each and every crew member, and in default thereof, to indemnify any of the releasees described above and hold them harmless in the event of any claims, demands, or actions brought against them by any crew member on the Owner/Skipper's boat.
- The Owner/Skipper acknowledges that it is the Owner/Skipper's responsibility to ensure that the boat carries all required safety equipment, in good order and that the crew are familiar with it's location and means of operation. The responsibility of wearing a life jacket rests upon the Owner/Skipper and their crew.
- The Owner/Skipper certifies that a valid marine insurance policy covering hull and machinery and liability is in full force and effect and that a copy of the policy will be on board the boat at all times when racing.
